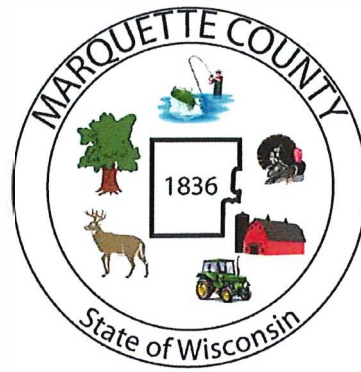

Permit Holders:

All Traffic Control associated with the permitted work in right of way must be in accordance with the guidelines set forth in *The 2020 Wisconsin Flagging Handbook*; published by the Wisconsin Department of Transportation; December 2019.

There will be no coring or hydro-excavation permitted under the roadway. All work under the roadway needing exposed utilities requires an open cut to allow for proper backfill using either base aggregate or unsaturated native material. Concrete, flowable fill, or slurry is not permitted for use as a backfill material.

In the event of an open cut in the roadway the Highway Department shall be notified and reserves the right to have a representative on site during the backfill and replacement of pavement to ensure restoration meets pre-project conditions. Proper backfill material, lift compaction, and pavement thickness can prevent settlement of pavement. The applicant also agrees to return and correct the settlement of the replaced pavement within 18 months of the restoration date.

When operating tracked equipment on the roadway the tracks must have rubber pads or the contractor is required to use tracking pads or tires to cross the pavement. There shall be no operation of heavy equipment on the roadway to eliminate the need for a semi to transport said equipment.

Failure to follow the guidelines set forth will result in the suspension of the awarded permit and/or potential withholding of future permits. In the event of any damage or settlement proper repairs will be completed, and the permit holder billed for costs incurred by Marquette County. Permit holders are responsible for oversight of contractors operating under their permit.

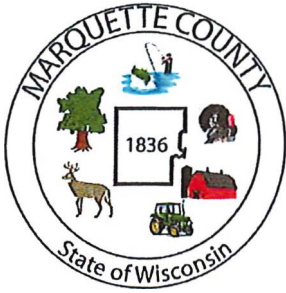

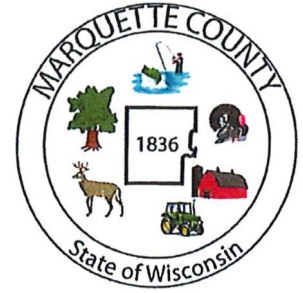
